

IMPORTANT GMWB Roll-Up Rate Change

Effective with the February 15, 2012 buy date, the guaranteed minimum withdrawal benefit roll-up rates will be reduced on the following fixed indexed annuity products:

	Current	New
FG AccumulatorPlus 10 and 14 FG Index-Choice 9	7.00% 7.00%	6.50% 6.50%
Prosperity Elite 7, 10 and 14	7.25%	6.75%

Please note that the roll-up rates will not be changed for FG Index-Accelerator 7 and 10. The roll-up rates will continue to be 4% and 6%.

Business Transition Rules:

In order to receive the current, higher roll-up rate:

- For cash with applications, all paperwork must be received in good order at the service center by Monday, February 6, 2012.
- For 1035 exchange applications, all paperwork must be received in good order at the service center by Tuesday, February 7, 2012.

For applications received after the above dates and later:

- All agents will be asked to cross out the current rate reflected on the application, handwrite the new rollup rate and have the client initial the change. For Prosperity Elite applications, please mark the proper roll-up rate on all applications submitted under the "special instructions" area of the application and have the owner initial the change (please see examples page two).
- Applications that are not marked and are/or are not initialed will be issued with an amendment that must be signed by the owner and returned to our service center.
